

## **Privacy Statement for Forward Farma**

This privacy statement explains what data we may collect when you use our website, why we collect it and what we do with it. We consider it important that your data are handled with care and ensure that the data you provide us with is treated confidentially. In some cases, the information you provide to us will contain personal data. This data can generally be traced back to a natural identifiable or identified person. In order to comply with the GDPR as much as possible, we have chosen to apply the same policy to all data you provide to us.

In short, our privacy statement declares that:

- a. we use data only for the purposes agreed upon;
- b. we will not share your data with others, unless this is necessary for the performance of our services or activities;
- c. we strive to secure your data adequately.

### **Why do we collect your data?**

We do not collect or use your data for purposes other than those described in this privacy statement, unless we have obtained your explicit prior consent.

### **Use of our services**

When you use our services, we ask you to provide data. This data is necessary for the provision of the services or the delivery of products and is stored by Forward Farma in accordance with the legal retention period.

### **Communication**

If you send us e-mails or other messages, these will be included in our systems and stored in accordance with the legal retention period. Sometimes we ask you for data relevant to a situation or question. This makes it possible to process your questions and answer your requests.

### **Forms**

The website contains forms that you can use to request or download information, download the newsletter, place orders, enter into agreements or get in touch with us on various subjects. We will retain the information you provide us with these forms for as long as is necessary or reasonable for the full answering and/or handling of your request. Your request can also be included in our systems and stored there in accordance with the legal retention period.

### **Third parties**

We use third parties in the performance of our services and activities, such as a hosting service. If these third parties have access to your data, we take appropriate measures to ensure that your data is adequately secured and used only for the intended purposes. Under no circumstances will Forward Farma sell your data to third parties.

## Security

Forward Farma has taken appropriate technical and organizational measures to protect the personal data you provide against unauthorized use.

Your data is transmitted over the Internet over secure connections (SSL/TLS protocol) and processed and stored in certified data centers and on Forward Farma servers. The data is protected from search engines.

Our employees are legally obliged to respect the confidentiality of your data. We also impose this obligation contractually on third parties engaged by us in the performance of our services and activities.

## Website visit

When you visit our website, the technical characteristics of your visit are recorded in so-called log files. For example, the requested page, IP address, time of day, browser type and the like. We do not check who uses which IP address at which time and we do not trace this data back to your person. These log files are only stored for analysis purposes.

## Cookies

Cookies are small pieces of information that your browser stores on your computer.
